## MOTION TO AMEND SCHEDULE SET FORTH IN ORDER GRANTING CLASS PLAINTIFFS' MOTION FOR PRELIMINARY APPROVAL OF CLASS SETTLEMENT WITH VNA DEFENDANTS [3009]

On June 17, 2024, the Court granted Class Plaintiffs' Motion for Preliminary Approval of Class Settlement with the VNA Defendants, issuing a schedule setting out remaining deadlines in the settlement process. ECF No. 3009. Class Plaintiffs suggest revising the schedule to shorten certain deadlines and thereby (1) allow the distribution of funds pursuant to the VNA Settlement to be coordinated with the distribution of funds under the MSA to the extent practicable, (2) maintain a longer period for claimants to register for the settlement to allow as many potentially eligible claimants as possible to obtain relief; and (3) in the event the Court grants final approval of the Settlement, allow the distribution of funds as soon as practicable. For the same reasons, Class Plaintiffs further request that the Court set the final approval hearing for some time in late September or early October.

Class Plaintiffs propose the following amendment to the Court's Order:
